2015 Annual Parish Meeting

2015/16/001

The Chairman, Cllr Colin Passey, opened the meeting at 7.03 pm and welcomed Cllr Mrs Bainbridge (MDDC) also returned members of the Parish Council. He also welcomed parishioners Mr David Sweatman, Mr Simon Bartlett, Mr Andrew Brown, Mr Robin Hazelton, Mrs Chrissie Holland and Mrs Christine Mason. Cllr Passey noted the election of Cllr Bainbridge and Mrs Christine Collis as MDDC Ward Members.

Apologies: none received.

2015/16/003

Minutes of the 2014 Annual Parish Meeting held on 13 May 2014 were read by the Clerk. It was noted that these Minutes had already (on 22 July 2014) been approved by the full Parish Council.

Matters arising - none.

2015/16/004

Chairman's annual report.

Cllr Passey presented his report for 2014/15. He expressed thanks to the Clerk, to the District and County Members, Cllrs Lucas, Bainbridge and Radford, to the Vice-Chairman, Cllr C Port, and to all Members for their support throughout the year. He noted that the year had been mostly free of contentious planning issues, however the proposal to construct a cattle transfer station had been opposed by many, but had received permission by MDDC Planning Committee. Proposals for development at J27 had been discussed at a public meeting: no actual planning application has yet been made by the developers. Another application that has caused much interest is the proposal by First Great Western to make permanent the temporary coach park on Station Road for use as an additional car park: it is hoped to incorporate a safe route to the station for pedestrians and 'cyclists in this development.

The establishment of Working Groups within the Parish Council has enabled attention to be paid to matters such as hedge and tree maintenance, the state of roads, and the problem of litter.

Cllr Passey explained that because of funding cuts imposed on County and District Councils, alternative ways of paying for some services have to be found. The contribution now required towards the upkeep of the public conveniences in Lower Town is but one example. It is anticipated that contributions towards grass cutting will be necessary in the future. For this reason there had had to be an increase in the Parish precept for 2015/16.

Cllr Passey paid tribute to Mel Lucas who had retired his seat on MDDC in the recent elections: he has contributed many years of service to both the Parish and District Councils. Also Charlie Port was thanked for his years of service as a Parish Councillor following his retirement from the Council. The full text of the Chairman's report will be published in "Parish News".

2014/15 accounts. The Clerk presented a summary income and expenditure account for the financial year to 31 March 2015 and then answered questions on the precept and the effect of Council Tax Support Grant, also on Section 137 payments. The accounts were noted.

Mr Brown reported his concerns regarding the visual obstruction caused by bushes where the A361 meets the roundabout at J27. This will be reported to Cllr Radford.

Mr Brown also spoke about the parking problems on Whitnage Road and of the increasing presence of dog muck in the village. Cllr Passey explained the involvement of the PC in these matters.

Mr Bartlett asked if MDDC is to close the amenity car park in Lower Town. There followed discussions on the problem of over-night parking and how this might be resolved.

Mr Hazelton referred to the new access to the 'Old Cattle Shed' in Lower Town. Its unfinished state has made the use of the grass verge by pedestrians rather hazardous. The involvement of MDDC's Enforcement Officer was explained and completion of the work will be urged.

Cllr Passey called for nominations for Vice-Chairman. Cllr Cutts was proposed by the Chairman and seconded by Cllr Sweatman. Cllr Cutts indicated his willingness to stand. There were no other nominations. All present indicated their agreement and thus Cllr Cutts was unanimously elected.

i) 15/00448/FULL: Mr M Johnson: erection of a dwelling: adj to Jersey Cottage, SP. Outside of settlement limit: not supported: noted.

ii) 15/00507/MFUL: First Great Western: new surface car park with associated lighting: land near Tiverton Parkway, SP. Supported in principle, but the extra traffic movements require mitigating measures to ensure safety of pedestrians and 'cyclists (footpath with lighting and 30/40 mph speed limit on Station Road): noted.

iii) 15/00460/FULL: Mr P Netherway: erection of an agricultural livestock building: Great Landside, Westleigh. No objection: noted.

iv) 15/00521/CAT: SPPC: notification of intention to fell 1 white beam and 1 silver birch, and to carry out works on 5 silver birch and 1 chestnut tree: recreation ground, Lower Town, SP. This is the Parish Council's application. The Clerk reported that MDDC is minded to impose a Tree Preservation Order on some of the trees concerned. Cllr Bainbridge to investigate.

Reports from County and District Councillors:

No County report in the absence of Cllr Radford.

Cllr Bainbridge spoke of the departure of several District Members at the recent elections. The first full council meeting has not yet taken place. MDDC Committee structures will then be determined.

2015/16/018

Working Groups: reports:

Community Safety: Cllr Sweatman had nothing to report. Papers concerning the Raddon Hills group of parishes (meeting held on 24 February 2015) had been circulated on 30.4.15.

Environment: Cllr Holland gave an update on proposed work on the Station Road triangle. The trees in the Recreation Ground are subject to a Conservation Area Consent application (see Planning matters, above). Cllr Mason told the meeting that the offer made for the 22 Lower Town property had been rejected by the vendor's agents.

Publicity: Cllr Culpin gave an update on the website.

Parish Plan/Funding: Cllr Cutts reported that two applications to the TAP Fund made in 2014/15 had been successful (Pavilion furnishings and Recreation Ground improvement). It is understood that the scheme will operate again in 2015/16.

It was agreed to defer agenda items 12 (Sampford Lands Charity: appointment of PC Trustees) and 14 (Annual walk of Parish footpaths, 2015) until a later date. The Chairman will devise a set of walks.

2015/16/020

Highways and other village matters:

a) Spring litter-pick: Cllr Passey expressed appreciation to all who took part. There had been appreciable quantities of litter found, and depressingly, more was seen after only a few days. It was suggested that the PC should purchase several sets of pickers, hi-viz jackets, bags and rings.

Cllr Holland to obtain quotes for 5 sets. This would enable a team of volunteers to pick on a continuing basis: volunteers to be sought via the website and "Parish News". The twice-yearly litter-picks will be retained. The School could be involved with an awareness campaign.

b) Housing Needs survey report: deferred to next meeting.

c) Footpath (amenity car park to Lower Town). Believed to be owned by MDDC. Action to be chased by Clerk.

2015/16/021

Finance:

a) Statement of Accounts: as at 2 May 2015 balances were as follows...

The payment of Devon Communities Together (Housing Needs survey fee of £300.00) has not yet been presented: payment will be made from the Parish Plan Group balance).

- iv) Sampford Peverell Magazine Fund: agreed donation for 2015/16: £200.00: (cheque amended to make payable to S Bartlett, who acknowledged with thanks this donation to the magazine).
- v) Sampford Peverell Village Hall & Recreation Ground Charity: agreed grant for 2015/16: £2,000.00.
- vi) D Sweatman: expenses re Spring litter pick as claimed: £14.35.

In addition two cheques were issued for grants from the 2014/15 TAP Fund

- £670.00 to the VH Charity for works to improve the Recreation Ground, and
- £550.00 to F Harding for equipment already purchased for the sports clubhouse/pavilion.

Eight cheques issued with the unanimous approval of Members.

Note: the annual insurance premium is due on 1.6.15. The present insurers, Aon Ltd, have quoted £553.83. A quotation in the sum of £358.81 for a comparable policy has been received from Zurich Municipal. Cllr Adlington will examine both policies and a cheque will be issued and sent ahead of the renewal date to Aon or Zurich as appropriate.

- c) Approval of accounts for 2014/15: the accounts statement was accepted on the proposal of Cllr Holland, seconded by Cllr Culpin, agreed *nem con* and signed by the Chairman and by the RFO.
- d) The arrangements for the internal audit and the appointment of Mr Steve Wright as Internal Auditor were approved on the proposal of Cllr Passey, seconded by Cllr Cutts and agreed *nem con*.
- e) External audit: approval of the statement of account and of the annual governance statement for 2014/15 (pages 2&3 of the Annual Return): proposed by Cllr Holland, seconded by Cllr Sweatman and agreed *nem con*.
Both sections of the Annual Return were signed by the Chairman and by the Clerk/RFO.
- f) Bank mandate: the Clerk stated that changes to the authorised signatories for the PC's bank accounts would be made following co-options to fill the two vacant seats.

MUGA funding: Stuart Brooks was invited to address the meeting. Stuart explained that he is the Chairman of the Youth Football Team and that following the merger of Uffculme and Sampford Peverell youth teams there is a total membership of about 160. They only have three pitches available for matches and training: there is a need for training facilities. The redundant tennis court in the sports field in Whitnag Road could be made into a multi-use games area (MUGA) and an application for continued.....

funding has been made to Viridor for £97,000. It is necessary for 10% to be raised locally: they already have £8,000. That 10% goes to Viridor who then release the grant. Stuart sought guidance on how the Parish Council will handle payments for work and re-claim the VAT element.

Stuart confirmed that £97k + VAT was the best and lowest of three tenders.

The Parish Council will set up a MUGA Committee comprising Cllrs Passey, Cutts and Adlington, to which Fred Harding and Stuart Brooks will be co-opted.

Ideal construction time is September and should take 3 weeks.

Stuart Brooks left the meeting at 7.30 pm.

2015/16/025

Sampford Lands Charity: appointment of Parish Council Trustees.

By letters the Charity has advised that it wishes to appoint, subject to PC approval, Mrs L Turner and Mrs E Sanderson (whose 3-year terms of office end in 2015), also Mrs P Harding and Mrs H Hirst (as Trustees to replace Mr G Conn). Appointment of all four will create more Trustees than the original Scheme adopted by the Charity Commission in 1895 allows, the other PC co-optees being Mrs J Wright and Mr D Sweatman. Clerk to write to the Charity's new Secretary, Mr L Jackson, for clarification.

2015/16/026

Annual walk of Parish footpaths, 2015.

Cllr Passey stated that the 2014 walks had not been a success, attracting very few participants. He feels that the walks need to have a more informal approach, perhaps ending at a pub. Cllr Passey will devise a revised series of walks to cover all footpaths in the Parish. Copies of the definitive map are available for all Members.

The Clerk spoke of a matter reported to him by Mrs Joan Baker (12 Boobery): the footpath from the Village Hall to Chains Road has three field gates: each gate has dropped on its hinges, making it very difficult to close properly. Mrs Baker is concerned because if a gate is not properly closed stock could stray. Cllr Passey to investigate, and with Cllr Sweatman's help, to contact the relevant farmers or owners to advise and to seek repairs.

2015/16/027

Reports by 2014/15 Parish Council representatives:

a) VH & RG Charity Committee: Charlie Port has retired from the Parish Council and from the VH & RG Charity Committee: no report available.

b) Canal Advisory Committee: Cllr Cutts had already circulated his report.

c) Sampford Peverell Society: Cllr Culpin's report included details of forthcoming visits and talks: it had already been circulated.

d) SP & District Twinning Association: the minutes of the meetings held on 12 April and 3 May 2015 had already been circulated.

e) Tree Wardens: Cllr Mason spoke to the report from Peter Bowers which had been circulated on 20.4.15. Peter referred to the grassed area adjacent to the car park entrance and the wish of the Tree Wardens to plant bulbs there. He raised the question of future maintenance of the area. The possible work to improve drainage of the adjacent footway would need to be done before any bulb planting. Cllr Mason also raised the possibility of changes to the car park with the possible introduction of a charging scheme by MDDC. The Chairman has already raised this with Cllr Collis (MDDC) seeking clarification and to ensure that local consultation takes place prior to the introduction of charging.

- a) Cllr Mason reported an incident when Chains Road was blocked by careless parking of a car: Graeme Cottrell had been unable to get a tractor and trailer passed. The meeting advised that the Police should have been immediately involved.

It was also emphasised that pot-holes and other highways defects should be reported to the DCC help desk and followed up as appropriate if action is not taken.

- b) Housing Needs survey: agreed that Cllrs Passey, Culpin and Mason will meet to consider the report, with further action to be decided at a future meeting of the PC.

c) Cllr Holland gave an update on the work on the Station Road triangle. She reported that John Hewitt may need a hired jack-hammer to assist with the erection of gate posts. Agreed that the Parish Plan fund monies could be used as necessary for this project.

d) Planning matters:

i) The Chairman will e-mail Cllr Bainbridge re the Station Road car park application which is with MDDC's Planning Committee on 3 June (nobody able to attend).

ii) Tree works in Recreation Ground: the Clerk gave an update on the PC's application for Conservation Area Consent. Disquiet was expressed that the personal views of the MDDC Tree Officer should determine the application, contrary to the views of a qualified tree surgeon. Suggested that a letter of complaint be sent to the CEO of MDDC objecting to a decision taken apparently on personal preference. [After the meeting further correspondence was exchanged with MDDC and a formal objection to the ratification of the Tree Preservation Order was made on behalf of SPPC by the Clerk. It is also known that the adjacent occupier has objected.]

There being no other business, the meeting was closed at 9.15 pm.
